ITEM NO. 1:

Confirmation of the Minutes of the last meeting of IQAC which was held on 18th June, 2018:

Nurturing Excellence:

Right to Education is one of the fundamental rights of every Indian citizen, DMIMS (DU) believes that money should not be a road block for a student with innovative ideas in his mind and passion in his heart. At DMIMS (DU) **Late APJ Abdul Kalam / Late Atal Bihari Vajpayee Scholarship** Programme proposes to extend Scholarships and Financial assistance to meritorious students based on their academic achievements.

A number of Scholarships are offered to students out of the student Welfare fund, Alumni fund and the funds received in the form of gifts from the University benefactors, depending on the academic credentials, achievement in clinical, sporting and cultural arena, the University grants full to partial waiver on tuition fees payable by the student.

The Scholarship proposes to support the students who have strong commitment and determination towards education.

It is a matter of pride to be called a Late APJ Abdul Kalam/ Late Atal Bihari Vajpayee Scholar. Staying true to our founder Honorable Dattaji Meghe's vision of rewarding the brightest and the best, a rigorous selection process shall be followed.

The Tuition fees waiver budget for the each academic year shall be decided at the beginning of the financial year by the Board of Management. This shall in no circumstances exceed 5% of the total fees receipts of the University for the said year.

Selection Procedure:

The Scholarships entail the following process:

- The applicants: students from the constituent institute shall be evaluated on the basis of the information given in the application form. The Students from the first year of their study till the final year of the degree/ postgraduate course are eligible to apply.
- Apart from consistent academic performance, an importance to participation in co-curricular/ clinical and extra-curricular activities. However the new entrants would be judged on the basis of their performance at the school/ UG level; whatever the case may be.
- After the initial screening of applications, candidates who are found suitable will have to undergo an online test which will be based on the lines of **Thinking Skills Assessment (TSA)**. The syllabus of the said test shall also include certain proportion of topics relating to the regional awareness.
- Students from each constituent unit shall be made eligible for scholarship on the basis of inter-se-merit in the test.

Higher Educational Achievers Recognition Track (HEART)

The DMIMS (Deemed to be University) has an enviable reputation for providing quality, student-focused education in a professional and friendly environment.

The Higher Educational Achievers Recognition Track (HEART) will be the only scheme of its kind in the Country which shall support students at University level to step on and step up and maximise their potential to become the best that they can be alongside their degree qualification.

DMIMS DU's core values are Excellence, Stakeholder Centricity, Meaningful Liaising , Fairness and integrity. Keeping in tune with the Core values, students accessing this scheme will tailor their own journeys through the scheme during their studies and will access any available opportunity provided by the scheme, through attendance at courses, seminars, events and workshops.

HEART shall provide enrichment opportunities across four tracks:

1. Personal and Professional development (PPD),
2. Advanced Academic Success (AAS),
3. Voluntary and Community Opportunities and
4. Internationalisation

Students will also have dedicated support from the HEART Consultant at DMIMS(DU). The Students can be referred into the scheme by nomination from programme level, or by self-nomination or recommendation.

1. Personal and Professional development (PPD):

Professional and personal development is an ongoing process and continues throughout a their professionals career. The scope of PPD is to develop skills and competencies that enhance their abilities in the domains of research, participation in professional organization, skill based training, approaches to professional development etc.

At the same time recognize their area of interest and encourage them to seek mentorship, participation in various competitions, establish blog or website of their own via social media etc to facilitate their personal development.

2. Advanced Academic Success (AAS):

Through recognising and developing academic success, we support and motivate the diverse student body and help facilitate education and leaders of tomorrow's workplace and society. Key benefits of AAS are to enhance the potential of students for academic success by **mastering the skills required, providing access to advanced resource materials** and find opportunities that lead to success. Students shall be given incentives for **presenting and /or publishing their research work** at national/ international forum.

The DMIMS (DU) Envisages that through the various collaboration with organizations of the International repute, some short term during curricula add-on programs can be started so as to encourage the HEART applicants for furtherance of their achievements

3. Voluntary and Community Opportunities:

Opportunities shall be provided to understand community diversity and develop qualities of **enthusiasm, flexibility, teamwork, communication and good organizational skills**. Those students with any **innovative ideas or schemes** to promote health at community level during their field visits shall be rewarded. The University shall also support the students in **organizing workshops** or students' **conferences or webinars**. **Activities which are already in vogue like YUVA shall be clubbed with this track.**

4. Internationalization :

Exploration of emerging perspective on the internationalization of higher education is important. The scope of internationalization is to learn alongside high achieving peers from around the world. University shall take the lead by providing opportunities to attend and present their research work at National and International forums, student exchange programs.

Assessment : For grading, e-Portfolio can be developed and maintained for their progress.
