Invitation for Applications of Doctoral Fellowship Program (JRF)

DMIHER (DU) is offering posts of Junior Research Fellows under the ambit of the Doctoral Degree Programme, across all faculties namely Medicine, Dentistry, Ayurveda, Pharmaceutical Sciences, Physiotherapy, Allied Health Sciences, Commerce and Management, Science and Technology, Engineering and Technology & Interdisciplinary Sciences.

The tenure for Fellowship under the DMIHER (DU) Doctoral Fellowship Program is for three [3] years and shall commence from the date of registration for Ph.D. (approval of synopsis by DRC).

The stipend for JRF shall be as follows:

- First Year Rs. 25000/- per month
- Second Year Rs. 26000/- per month
- Third Year Rs.27000/- per month
- 1. The JRF shall devote full time to research during the tenure of the fellowship and will not be permitted to take any part-time/full-time assignments.
- 2. The nature of the candidature [Full-time Doctoral Fellow) will not be changed during the program.
- 3. The Ph.D. rules/regulations and disciplinary rules of the University will be applicable to all admitted candidates under this Program.
- 4. The JRF shall furnish an undertaking that in case ofleaving the seat within the duration of Fellowsh ip, he/she shall be liable to refund the entire amount of stipend received by him/her till the date of his/her leaving the Program.
- 5. The Ph.D. Scholars shall be admitted under the Doctoral Fellowship Program of DMIHER (DU) and shall not have any claim to a job, or any other claim related to employment in DMIHER (DU).
- 6. Total vacancy of Junior Research Fellows is 25.
- 7. The JRF shall publish minimum 3 research papers
- 8. Date of interview is 30th May 2025. The Interested candidates should submit their application expressing interest in appointment as JRF to the Directorate of Advanced Learning by 27th May 2025

- 10. Only those candidates who had enrolled for the Ph.D. program are eligible for the post of JRF. The Fee structure for the JRF candidates will be as per the policy.
