Selection Procedure:

The Freeship entail the following process:

- The applicants: students from the constituent institute shall be evaluated on the basis of the information given in the application form. The Students from the first year of their study till the final year of the degree/ postgraduate course are eligible to apply.
- Apart from consistent academic performance, an importance to participation in co-curricular/ clinical
 and extra-curricular activities. However the new entrants would be judged on the basis of their
 performance at the school/ UG level; whatever the case may be.
- After the initial screening of applications, candidates who are found suitable will have to undergo an
 online test which will be based on the lines of Thinking Skills Assessment (TSA). The syllabus of the
 said test shall also include certain proportion of topics relating to the regional awareness.
- Students from each constituent unit shall be made eligible for freeship on the basis of inter-se-merit in the test.
