### **UNDERTAKING**

I, ..... the undersigned is seeking admission to BDS Course of Sharad Pawar Dental College Under the Faculty of Dentistry under Datta Meghe Institute of Medical Sciences (Deemed to be University), on ..... I hereby give an undertaking that I have read the rules mentioned below thoroughly and I assure the authorities that I shall strictly abide by the same. I have been given to understanding that breach of discipline of any kind shall invite strict disciplinary action against me as per the rules of the University.

1. **Dress Code:**

Wearing of jeans/t-shirts is strictly prohibited in the Hospital premises while on duty. Wearing of formal shirt and trousers for boys and Salwar suit/or saree for girls along with white coat i.e. (apron) is mandatory.

2. **Behavior with the Patients:**

The behavior with the patients must be polite, cordial with sympathy and empathy. Any kind of aggression or misbehavior with the patients shall be viewed very seriously.

3. **Possession of 4-wheeler:**

Using or possessing 4-wheeler in the campus is strictly prohibited and no request to this effect shall be entertained. Any unauthorized possession of 4-wheeler shall amount to rustication from the College for a minimum period of three months.

Similarly while attending to official duties such as camps etc., the resident shall use only official transport and shall not use his/her own vehicle.



4. **Hostel Discipline:**

As per the norms of the Apical Councils, Post Graduate programs are residential in character thereby staying in the allotted premises in the campus (hostel) is mandatory. Moreover, considering the safety of the student, staying in hostel is highly recommended. Under these circumstances **"HOSTEL ADMISSION SHALL BE COMPULSORY AND NO ONE SHALL BE GRANTED PERMISSION TO STAY OUTSIDE THE CAMPUS"**.

Wardha is a sacred land blessed by auspicious presence of Father of the Nation Mahatma Gandhi. Hence, the District has been declared as dry district by Govt. of India and Govt. of Maharashtra. Possession or consumption of alcohol in the campus is strictly prohibited. In case of any violation, the resident shall be liable for rustication for a period of minimum one term (six months).

5. Similarly any acts of indiscipline such as aggressive behavior, possession or consumption of contrabands, damage to property of University, indulging in acts of assault shall be dealt with very strictly and rustication for a period of one i.e. 6 months shall be enforced in case of any breach of hostel discipline.

6. **Ragging:**

Is a punishable offence as per the directives of Hon'ble Supreme Court of India and the Raghavan Commission recommendations. Any student involved in acts of ragging shall be liable for permanent expulsion from the Institution.
