**Notification For Entrance Test DMIHER-CET-2024 For Basic B. Sc. (Nursing)**

**Smt. Radhikabai Meghe Memorial College of Nursing**

Applications are invited from eligible candidates for the **DMIHER-CET-2024**. DMIHER-CET-2024 shall be conducted for the admissions to the **Basic Bachelor of Science Nursing (B. B. Sc. Nursing)** program for the academic session 2024-25.

**Eligibility:**

- The candidate should have passed Standard 12<sup>th</sup> (10+2) or its equivalent examination with subjects, Physics, Chemistry, and Biology and secured minimum 45% marks (135 Marks Out of 300) taken together and passed in English individually for general category and for other backward class candidates 40% marks (120 Marks Out of 300) taken together and passed in English individually in the subjects Physics, Chemistry, and Biology.
- Should have completed 17 years of age on or before 31/12/2023.
- Candidates who are appearing in 12th Science State Board / CBSE/ ICSE or any equivalent examination in the year 2024 are eligible to apply.

- The date of declaration of result is **15<sup>th</sup> May, 2024**.
- Admission schedule and counseling dates shall be communicated separately to the eligible candidates.
- The admissions shall be done based on the inter-se-merit of marks obtained in the DMIHER-CET-2024, strictly based on merit.
- The candidates with at least 50% marks(45% Marks for reserved Category) in DMIHER-CET-2024 will be eligible for admission.
- Rules of Tiebreaker – In case of two candidates having similar marks in DMIHER-CET-2024, the following tiebreaker criteria shall be followed:
  - The one who has higher marks in PCB group of HSC examination shall be preferred.
  - If the tie still persists, then candidate with higher marks in Biology in 12<sup>th</sup> standard shall be preferred.
  - If the tie still persists, the candidate with higher marks in Chemistry in 12<sup>th</sup> standard shall be preferred over the younger candidate.
  - If tie still persists, a candidate with higher percentage of aggregate marks at SSC shall be preferred
  - If tie persists, an older candidate shall be preferred over a younger candidate

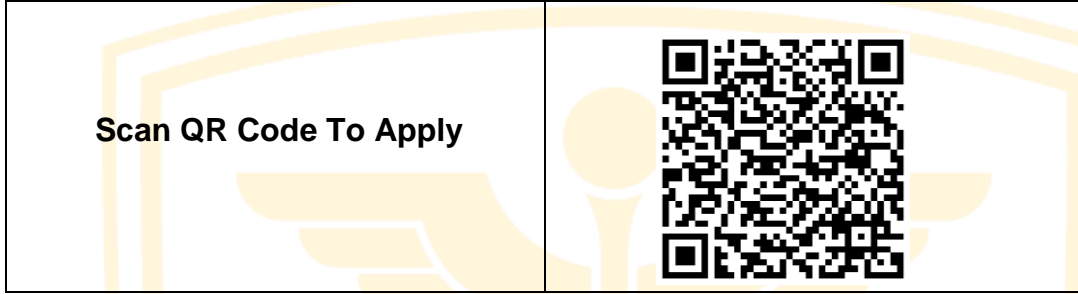
