Candidate must have passed 10+2 examination with Physics/ Mathematics / Chemistry/ Computer Science/Electronics/Information Technology/ Biology/Informatics Practices/ Biotechnology/ Technical Vocational subject/ Agriculture/ Engineering Graphics/ Business Studies/Entrepreneurship (Any of the three) and obtained at least 45% marks (at least 40% marks, in case of candidates belonging to the reserved category of Maharashtra State only) in the above subjects taken together.
- 2. Should have qualified for any one entrance examination out of DMIHER-CET-2024/MHT-CET-2024/JEE Mains-2024/Other State CET-2024.
- 3. Candidates who are appearing in 12th science State Board / CBSE/ ICSE or any equivalent examination in the year 2024 are eligible to apply.
