NOTIFICATION FOR ENTRANCE TEST DMIHER-CET-2024
Datta Meghe College of Pharmacy

Applications are invited from the eligible candidates for the **DMIHER-Common Entrance Test-2024**, which shall be conducted for **admissions to the Bachelor of Pharmacy (B. Pharma – 4 Years Degree Program) and for Pharm D (Doctor of Pharmacy – 6 years Degree Program)** for the academic session 2024-25.

Eligibility:

For B. Pharm Program: The candidate should be an Indian National and should have passed Higher Secondary School Certificate (10+2) Examination of Maharashtra State Board of Secondary and Higher Secondary Education or from CBSE board or ICSE board or its equivalent examination with subjects English, Physics, Chemistry and Biology or Mathematics and secured minimum 45% marks (40% marks for Backward class category candidates) in the subjects Physics, Chemistry and Biology/or Mathematics.

- **For Pharm D. Program*:** The candidate should be an Indian National and should have passed Higher Secondary School Certificate (10+2) Examination of Maharashtra State Board of Secondary and Higher Secondary Education or from CBSE board or ICSE board or its equivalent examination with subjects English, Physics, Chemistry and Biology or Mathematics. **OR** The candidate should have passed in Diploma in Pharmacy program.

*Subject to approval from PCI

Candidates who are appearing in 12th Science State Board / CBSE / ICSE or any equivalent examination in the year 2024 are eligible to apply.

Syllabus for Examination:

The questions will be based on syllabus of Maharashtra State Board of Secondary and Higher Secondary Education (Std. 12th Science) for Physics, Chemistry, Biology and Mathematics subjects.

Pattern of examination for both B Pharm and Pharm D. DMIHER-CET-2024:

- Pattern of examination: **150 MCQ of Physics, Chemistry, Biology, and/or Mathematics.**
- Distribution of Questions:

Subject	No. of questions	Marks
Biology/Mathematics	50	100
Chemistry	50	50
Physics	50	50
Total Questions	150	200

***Note:** If the candidate wants to appear for both biology and mathematics papers extra 30 minutes will be allotted to the student for additional 50 Questions.

- The date of declaration of result is **15th May, 2024.**
- Admission schedule and counseling dates shall be communicated separately to the eligible candidates.
- The admissions shall be done on the basis of the inter-se-merit of marks obtained in the DMIHER-CET-2024, strictly on the basis of merit.
- The candidates with a non-zero score in DMIHER-CET-2024 will be eligible for admission.
- Rules of Tiebreaker – In case of two candidates having similar marks in DMIHER-CET-2024, the following tiebreaker criteria shall be followed:
 - The one who has higher marks in PCB/PCM (whichever is higher) group of HSC examination shall be preferred.
 - If the tie still persists, then aggregate marks of HSC shall be considered and the candidate having higher aggregate marks shall be preferred.
 - If the tie still persists, the older candidate shall be preferred over the younger candidate.

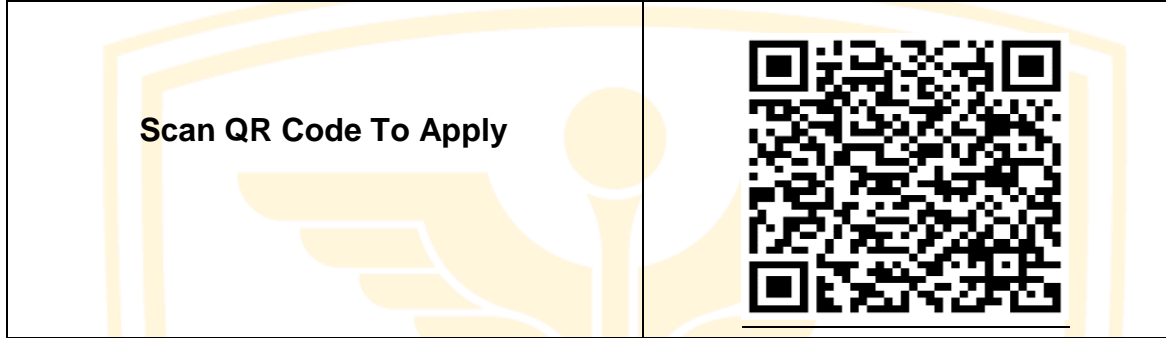
