- Duly filled application forms along with application fees of Rs. 500/- to be submitted via the payment portal provided in the application form.
- A confirmation mail and SMS will be received by the candidate once the application form fees are successfully paid.
- Candidates will be considered for selection based on marks obtained in PCB/PCM group of HSC examination and strictly on the basis of merit.
- Rules of Tiebreaker:
  - In case of equal marks in PCB/PCM group at HSC, a candidate with higher marks in Biology/Mathematics will be preferred.
  - If the tie still persists, a candidate with higher marks in Physics in HSC Examination will be Preferred.
  - At third level, a candidate with higher marks in Chemistry in HSC shall be preferred.
  - If tie persists, then a candidate with higher percentage of aggregate marks in HSC shall be preferred.
  - If tie still persists, then an older candidate shall be preferred over a younger candidate.
