Applications are invited from the eligible candidates for the **DMIHER-CET-2025**, which shall be conducted for admissions to the **Bachelor of Pharmacy (B. Pharm – 4 Years Degree Program)** and for **Pharm D. (Doctor of Pharmacy – 6 years Degree Program)** for the academic session 2025-26.

Eligibility:

For B. Pharm Program: The candidate should be an Indian National and should have passed Higher Secondary School Certificate (10+2) Examination of Maharashtra State Board of Secondary and Higher Secondary Education or from CBSE board or ICSE board or its equivalent examination with subjects English, Physics, Chemistry and Biology or Mathematics and secured minimum 45% marks (40% marks for Backward class category candidates) in the subjects Physics, Chemistry and Biology/or Mathematics.

- **For Pharm D. Program:** The candidate should be an Indian National and should have passed Higher Secondary School Certificate (10+2) Examination of Maharashtra State Board of Secondary and Higher Secondary Education or from CBSE board or ICSE board or its equivalent examination with subjects English, Physics, Chemistry and Biology or Mathematics. **OR** The candidate should have passed in Diploma in Pharmacy program.

Candidates who are appearing in 12th Science State Board / CBSE / ICSE or any equivalent examination in the year 2025 are eligible to apply.

Pattern of examination for both B Pharm and Pharm D. DMIHER-CET-2025:

- Pattern of examination: **100 MCQ of Physics, Chemistry, Biology, General English, Quantitative aptitude and Reasoning ability.**
- Distribution of Questions:

- Admission schedule and counseling dates shall be communicated separately to the eligible candidates.
- The admissions shall be done on the basis of the inter-se-merit of marks obtained in the DMIHER-CET-2025, strictly on the basis of merit.
- The candidates with a non-zero score in DMIHER-CET-2025 will be eligible for admission.

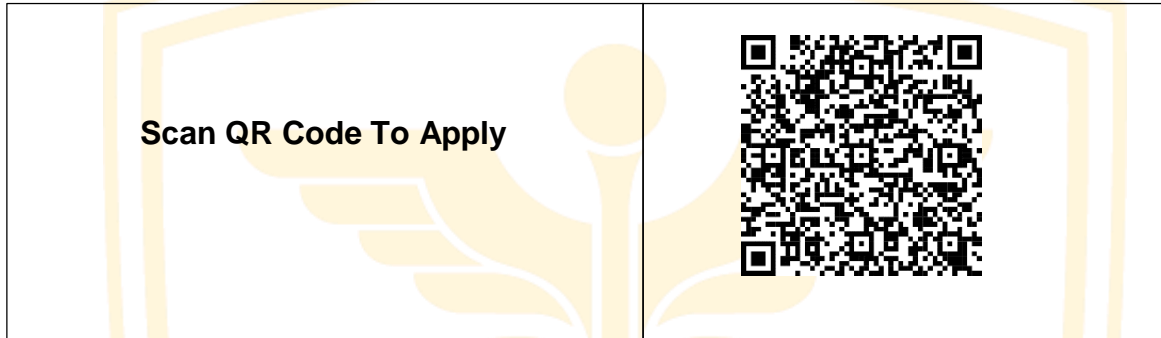

- Rules of Tiebreaker – In case of two candidates having similar marks in DMIHER-CET-2025, the following tiebreaker criteria shall be followed:
 - The one who has higher marks in PCB/PCM (whichever is higher) group of HSC examination shall be preferred.
 - If the tie still persists, then aggregate marks of HSC shall be considered and the candidate having higher aggregate marks shall be preferred.
 - If the tie still persists, the older candidate shall be preferred over the younger candidate.
- Duly filled application forms along with application fees of Rs. 500/- to be submitted via the payment portal provided in the application form.
- The candidate will receive a confirmation mail and SMS once the application form fees are successfully paid.
