- The date of declaration of result is 12.09.2025
- Admission schedule and counselling dates shall be communicated separately to the eligible candidates.
- The admissions shall be done on the basis of the inter-se-merit of marks obtained in the DMIHER-AIPGPCET-2025, strictly on the basis of merit.
- The candidates with a non-zero score in DMIHER-AIPGPCET-2025 will be eligible for admission.
- Rules of Tiebreaker In case of two candidates having similar marks in DMIHER-AIPGPCET-2025, the following tiebreaker criteria shall be followed:
  - The one who has higher marks in the BPT Final Examination shall be preferred.
  - If the tie still persists, then candidate with cumulative higher marks in all 4 years of BPT Course shall be considered and the candidate having higher cumulative marks will be preferred.
  - If tie persists, an older candidate shall be preferred over a younger candidate.


